approximately four feet below the surrounding uplands. The closest jurisdictional wetland is approximately 1,150 feet from this feature and there are no ditches connecting this features to another wetland. The surrounding soil is a sandy, upland soil type (Lakeland) classified by the NWI as upland (U11).
