jurisdictional. These wetlands within the project area were determined to be isolated due to the following reasons: the wetlands are completely encompassed by areas that do not meet the three parameters that define a wetland outlined in the 1987 Wetland Delineation Manual and/or Coastal Plain supplement and therefore disrupts any possible hydrologic connection to other wetlands or Waters of the US. In addition, the wetland has no discernable or traceable outfall or connection to other Waters of the US. The wetlands are performing functions; however, it has been determined that the wetlands are not adjacent to an RPW and do not support the biological, chemical, and/or physical integrity of any traditional navigable water.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The project area, in addition to containing jurisdictional wetlands, is comprised of two wetlands totaling 0.459 acres that were determined to be isolated (non-jurisdictional). The entire perimeters of the both wetlands were observed on the site visit dated June 28, 2012. The wetlands are completely surrounded by soils that do not meet any hydric soil indicators and therefore considered uplands. The site visit revealed that there are no surface or shallow subsurface connections to other waters of the United States. All water contained within the wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernible outfalls, topographic grades, and lack of evidence of chemical or biological connections, the wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the United States. Wetlands are located approximately 400 yards from a verified tributary. Nearest tributary is located due north.

Isolated, non-jurisdictional wetlands were coordinated with USACE Headquarters and EPA on June 29, 2012.

In addition, the site contains two (2) jurisdictional wetlands documented on basis form 2 of 2.
