Explain: There are 65 isolated wetlands on the subject property. These features fall into two categories: depressional areas with a distinctive topographic change and shallow depressions which have been heavily manipulated over 50 years of constant silvicultural practice including disking, plowing, windrowing and planting associated with pine production. These isolated

wetlands range from 0.0945 acres to 3.8784 acres in size, from 1 foot to 4.7 feet in depth below the surrounding uplands and from 78 feet to 1,230 feet from the nearest jurisdictional wetland. There is no surface or apparent subsurface hydrologic connection to the jurisdictional wetlands, no apparent chemical connection, or any apparent biological connection, including any evident ecological interconnectivity. In addition, there is no apparent connection to interstate or foreign commerce.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** There are 65 isolated wetlands on the subject property. These features fall into two categories: depressional areas with a distinctive topographic change and shallow depressions which have been heavily manipulated over 50 years of constant silvicultural practice including disking, plowing, windrowing and planting associated with pine production. These isolated wetlands range from 0.0945 acres to 3.8784 acres in size, from 1 foot to 4.7 feet in depth below the surrounding uplands and from 78 feet to 1,230 feet from the nearest jurisdictional wetland. These isolated areas have been checked carefully in the field to make sure there are no connections to jurisdictional systems. There is no surface or apparent subsurface hydrologic connection between the jurisdictional wetlands and the isolated features. Accordingly there is no visible chemical connection with jurisdictional wetlands, or any apparent biological connection, including any evident ecological interconnectivity. In addition, there is no apparent connection to interstate or foreign commerce.
