C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

It flows into Bates Pond, which is an impounded tributary. From Bates Pond, water flows to Quimby Creek and then to the Cooper River located to the north. Perennial RPW 2 is visible on the USGS topographic maps as a blue line and is also visible through aerial infra-red photography. Perennial RPW 2 and it's abutting wetlands can be seen on the National Wetlands Inventory as a palustrine, forested wetland (PFO1). Soil survey maps indicate that this Perennial RPW is located entirely within the Pantego fine sandy loam map unit; a poorly drained hydric soil.**

The National Wetlands Inventory identifies the larger wetland system as a broad-leaved/needle-leaved, deciduous, palustrine, forested wetland system that is contiguous with the Perennial RPW. Soil survey maps identifies the larger wetland by a mixture of hydric soil map units (Rains fine sandy loam, Pickney loamy fine sand, Pamlico muck) that abut with the hydric soil map unit that identifies Perennial RPW 2 (Pantego fine sandy loam).**

B. ADDITIONAL COMMENTS TO SUPPORT JD: This document determines the jurisdictional status of Wetlands A & B which are located on the 440.46 acre tract identified by the Berkeley County TMS # 2400000070, Berkeley County, South Carolina. On the USGS topographic maps is a blue line that originates just at the south perimeter of Wetland B and continues southward outside of the property boundary to off-site wetlands. Corps personnel walked the southern and eastern perimeter of Wetland B and found no RPW or conveyance feature where this blue line was located. When Corps personnel went to the location of where the blue line was supposed to be on the property they did not find a blue line RPW. Instead, Corps personnel found a gravel dirt road and an adjacent herbaceous field equipped with a power line overhead that runs adjacent to the properties' eastern border. Based on an on-site inspection, aerial photography, soil survey maps, and NWI maps, it is determined that Wetlands A & B are within Army Corps of Engineers jurisdiction under the Clean Water Act.
