Additionally, each of these isolated wetlands are topographically depressed, keeping the water within the

wetlands during storming events. During the site visit (June 12, 2012) Corps personnel saw no evidence of matted down, bent, or absent vegetation, no sightings of water staining, or any other evidence that could indicate an existing drainage pattern or surface flow coming out of these wetlands that would provide a flow between these isolated waters and other waters of the United States. All of these wetlands are completely surrounded by an upland pine forest with the exception of wetland G, which is bordered on it's south eastern side by an upland herbaceous field.

For all of the isolated waters there were no apparent shallow subsurface hydrological flow connections to waters of the United States. In addition, the isolated wetlands do not exhibit any chemical, biological, or physical connection to waters of the United States. There also appears to be no ecological interconnectivity with waters of the United States.

The isolated wetlands are not subject to the Clean Water Act regulation as they have no apparent connection to interstate or foreign commerce.

## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B.** ADDITIONAL COMMENTS TO SUPPORT JD: This document determines the jurisdictional status of Wetlands C, D, E, F, G, H, L, & M. These non-jurisdictional isolated waters are located on the 440.46 acre tract identified by the Berkeley County TMS #

2400000070, Berkeley County, South Carolina. Based on an on-site inspection, aerial photography, soil survey maps, and NWI maps, it is determined that these isolated waters are not subject to Army Corps of Engineers jurisdiction.
