C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. The site visit was performed during a period of normal climatic conditions. Soils were determined to be non-hydric. No hydrology indicators were noted within the review area. A prevalence of hydrophytic vegetation was observed in the remaining vegetated area within the review area. Soil surveys depict the site as non-hydric soils (Fuquay). The heat signature from the aerial infrared photographs appears to be consistent with upland forest. A man-made linear feature was observed within the review area. The feature had bed and banks but did not have an OHWM. The feature is not depicted on USGS Topo maps and was determined to be a non-jurisdictional ditch. No other potentially jurisdictional features were observed within the review area.
