C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 3.88 acre wetland on-site extends off-site as part of a larger wetland system. This system is contiguous with and surrounds Spencer Branch which flows to Eagle Creek which flows to the Ashley River, a TNW. The 0.11 acre wetland was part of the larger system previously. A portion of it was filled to make the roadway for the subdivison and mitigation was required as part of the NWP (SAC#2002-1670) that authorized the fill. The property has been sold and the new owner is moving forward to complete the mitigation that was not completed by the previous owner. It is noted that a wetland separated by a man-made berm/road does not sever jurisdiction, therefore this 0.11 acre wetland remains jurisdictional. Based on a site inspection, soil survey data, aerial photos, and quad/topo sheets, and review of the previously issued NWP #2002-1670, it is the determination of this office that the 3.88 acre and 0.11 acre wetland are jurisdictional.
