property line had an OHWM and inundated channel within bed and banks. The bottom is covered in last fall's leaves, indicating that there is little to no flow within the bed and banks. At the northwest end of the feature, inundation is present and minnows were observed in the bottom channel. The feature was determined to be excavated out of uplands and draining only uplands. No evidence of a manipulated natural system was present as the soils were non-hydric so it was determined to be entirely man-made and is not a man-altered tributary. No other jurisdictional features were observed on the site.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. The site visit was performed during a period of normal climatic conditions. Soils were observed to be non-hydric on the lowest point within the review area. The majority of the review area consisted of paved roads and a institutional educational facility with athletic fields, manicured lawns, and parking areas. No hydrology indicators were noted within the review area. Soil surveys depict the site a a mixture of hydric (Bladen) and non-hydric soils (Wahee). The heat signature from the aerial infrared photographs appears to be consistent with uplands. No features were depicted on the USGS Topo map within the review area. Three potentially jurisdictional features were observed during the site visit. Two linear features were determined to be outside of the review area after consultation with the property owner. One linear feature on the west property line had an OHWM and inundated channel within bed and banks. The bottom is covered in last fall's leaves, indicating that there is little to no flow within the bed and banks. At the northwest end of the feature, inundation is present and minnows were observed in the bottom channel. The feature was determined to be excavated out of uplands and draining only uplands. No evidence of a manipulated natural system was present as the soils were non-hydric so it was determined to be entirely man-made and is not a man-altered tributary. No other jurisdictional features were observed on the site. No waters of the United States were observed within the review area.
