### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This document verifies the jurisdictional status of only the upland portions of Tract-W, TMS # 267-00-00-151, located northeast and adjacent to Charleston Regional Parkway, Berkeley County, South Carolina. The wetlands and wetland buffer found on at the eastern end of Tract-W are under restrictive covenants and were verified as a part of the DA Permit SAC

1998-11425 (FKA: 98-1A-119-C). For information on the jurisdictional status and line verification of the wetlands and wetland buffer found on Tract-W, please refer to DA Permit SAC 1998-11425 (FKA: 98-1A-119-C).

The upland portion of Tract-W consists of 9.36 acres of upland deciduous forest. The data point taken in the upland portion of the property contained no hydric soils or wetland hydrology. The USDA web soil survey shows the upland portion to be comprised of a non-hydric soil map unit (Chipley-Echaw complex). Additionally, the national wetland inventory web maps determined that the upland area showed no wetlands. Based on the aforementioned data, the 9.36 acres of upland are not under Army Corps of Engineers jurisdiction under the Clean Water Act.
