C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This document determines the jurisdictional status of waters of the United States, including wetlands, found on TMS# 343-07-00-048, TMS# 343-07-00-049, and the "New Lot X". These three adjacent lots totaling 1.08 acres are located east and adjacent to Howle Avenue, Charleston, South Carolina.

Lots TMS# 343-07-00-048 and TMS# 343-07-00-049 both consists of an upland mowed lawn at the eastern back of the property and one residential house each on the western portion of the property near Howle Avenue. The "New Lot X", which is located between the two aforementioned lots, contains a broad-leaved upland deciduous forest that covers the eastern and center portions of the "New Lot X". Corps personnel walked into this deciduous forest from Howle Avenue to the eastern edge of the property and found no wetlands or waters of the United States. The 3 lots are surrounded by business complexes to the east and similar residential lots to that of TMS# 343-07-00-048 and TMS# 343-07-00-049 to the north, west, and south. The National Wetland Inventory data indicates that no wetlands exist on the property. Additionally, Charleston soil map information indicates that 3 soils divide up the property, all either partially hydric or not hydric (Kiawah loamy fine sand, Edisto loamy fine sand, and Seabrook loamy fine sand.)

There are no waters of the United States or wetlands located on any of the three lots and, and as such, the combined 1.08 acre property is not subject to Army Corps of Engineers jurisdiction under the Clean Water Act.
