Explain: **There are two small isolated wetlands on the northwest portion of the subject property. These features are addressed on Form 2. There are also 26 upland dug man-made conveyances (agricultural ditches) totaling 18,984 feet in length. These are generally 3 feet wide and two feet deep, are fully vegetated with upland vegetation, exhibit no flow, and have no ordinary high water marks and were therefore determined to be non-jurisdictional. There is also a man-**

made conveyance along the western property boundary that is 3,340.65 feet long, eight feet wide and two feet deep. This feature drains property offsite to the north. It was dry at the time of the site visit. Since it is dug from uplands, exhibits no flow and has no ordinary water mark, this feature was determined to be non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form documents 6.25 acres of tidal jurisdictional wetlands associated with Gray Bay. Since they are tidal, these areas are both TNWs and Section 10 waters. A 0.08 acre RPW is also documented which flows directly into tidal waters mentioned above. There are also 26 upland dug man-made conveyances (agricultural ditches) totaling 18,984 feet in length. These are generally 3 feet wide and two feet deep, are fully vegetated with upland vegetation, exhibit no flow, and have no ordinary high water marks and were therefore determined to be non-jurisdictional. There is also a man-made conveyance along the western property boundary that is 3,340.65 feet long, eight feet wide and two feet deep. This feature drains property offsite to the north. It was dry at the time of the site visit. Since it is dug from uplands, exhibits no flow and has no ordinary water mark, this feature was determined to be non-jurisdictional.
