# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.



**B.** ADDITIONAL COMMENTS TO SUPPORT JD: The entire project area is comprised of uplands. The project area has a previous determination dated June 16, 2006 where the project area was determined to be comprised of uplands. A recent site visit dated November 10, 2011 revealed the same findings as the June 16, 2006 determination of the site containing potential wetland areas. These potential wetland areas are comprised of hydrophytic vegetation, hydric soil (in some locations), however lacked indicators of hydrology. The project area is surrounded by a golf course, residential housing and land cleared areas with drainage features.
