C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: No wetlands were discovered using the 1987 Wetland Delineation Manual. The subject site is mapped with Lynchburg (not hydric) and Rains (hydric) soils. A soil pit at the lowest elevation within the review area determined that no hydric soil indicators were met. No hydrophytic vegetation was discovered and vegetation is entirely upland grass species (cultivated). No hydrology was present within the review area. The entire review area is depicted on the NWI maps as U12, uplands. No potentially jurisdictional features were noted and no waters of the US were discovered within the review area.
