C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Onsite wetlands within the project area have been previously placed in restrictive covenants for impacts associated with a Department of the Army Nationwide Permit #39 verified on September 5, 2006 and documented in SAC 2006-01137-3NH. In addition, these wetlands are protected by adjacent upland buffers. The project area contains 10.10 Preserved Wetlands with 2.40 acres of associated upland buffers. Additionally, the waters onsite were previously reviewed and found to have a positive SND to the downstream TWN in a letter dated May 20, 2010 for 2009-01021-3JH, Tuscan Development (previous determination September 9, 2004 81-2003-0665). "This significant nexus determination covered the entire drainage area (+/- 2,200 acres) of Cross Swamp starting just south of Legends road and terminating just east of U.S. Highway 501 at its confluence with Socastee Swamp, a larger order stream."

Lots 184, 182, 181 and 164 contain portions of impounded WOUS and upland areas. The upland areas of each lot contained hydrophytic vegetation (*Pinus serotina*, etc) and hydric soils (Leon) however lacked indicators of hydrology. Previous site visit to the surrounding area is documented in SAC 2011-00960-3JY, letter dated 9/26/11 as well as the stormwater management plan for this development.

The waters in the project area, in part, flow through a series of lakes excavated from previously determined wetlands (SAC 81-2005-1463-3 & wetlands preserved under NWP#39 -SAC 2006-1137-3NH) that discharge into an offsite man-made PRPW determined to be jurisdictional in a letter dated January 24, 2011 (SAC-2006-00757-3JH). Portions of wetlands within the project area continue offsite and considered non-abutting to the above described offsite tributary; separated by a man-made berm/access road. In the determination(SAC-2006-00757-3JH), the PRPW was identified in the basis form 1 of 3 and described as a man-made tributary with perennial flow. Flow of the offsite tributary is to Socastee Swamp which discharges into the AIWW. The nearest TNW is the point where Socastee Swamp is tidally influenced just before discharging into the AIWW.
