If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The seasonal RPW on site is located on the western side of the tract. It is performing a variety of biological, chemical, and physical functions that effect the integrity of the TNW (Congaree River). The tributary is located in a highly developed area. It provides habitat for and foraging areas for water dependant species. This tributary also provides breeding ground and shelter for aquatic wildlife in an area that has a lot of development and not a lot of areas for wildlife. This tributary also collects runoff from nearby developments and uplands and helps to filter the pollutants before they go to the downstream TNW. This tributary provides storage for flood waters during the wetter months and times of heavy rain. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the TNW, it has been determined that there is a significant nexus between the tributary and the downstream TNW.

D. DETERMINATIONS OF JURISDICTIONAL FINDINGS. THE SUBJECT WATERS/WETLANDS ARE (CHECK ALL THAT APPLY):

Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. It has a wide, shallow channel that spreads out and becomes a braided wetland system on-site. A seasonal on-site tributary flows into the braided system and is piped off-site. Water was observed flowing in the channel at the time of flagging and during both site visits with the Corps. The tributary is located in a highly developed area and receives runoff from the adjacent uplands. Stream characteristics observed and available data indicate perennial flow.**

Tributaries of TNW where tributaries have continuous flow “seasonally” (e.g., typically three months each year) are jurisdictional. Data supporting this conclusion is provided at Section III.B. Provide rationale indicating that tributary flows seasonally: **Trib 174 has been manipulated through piping and is piped at the beginning and the end of the tributary. A small amount of water was observed in the tributary during the site visit with the Corps. The tributary is no more than 3 feet wide and is a first order tributary. The tributary has a clear OHWM and contour signature on the topo indicates topography conducive to the formation of a tributary. Stream characteristics observed and available data indicate seasonal flow.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: Aquatic resources on the site include 1 seasonal RPW (174 linear feet), 1 perennial RPW (370 linear feet), and an abutting wetland (0.73 acres). Based on guidance in RGL 07-01, the perennial RPW and abutting wetland documented on this form are within the jurisdiction of the Clean Water Act. The seasonal RPW is jurisdictional according to RGL 07-01, however, significant nexus findings for the record are included as required by Rapanos Guidance. Therefore, the waters documented on this form are jurisdictional Waters of the U.S.
