Summarize rationale supporting conclusion that wetland is “adjacent”: **The subject project area is located within a maintained powerline easement. The wetlands do not continue offsite, but the adjacent areas appear to have been filled in the past. The area surrounding the subject project area consists of a golf course, ponds, and a residential subdivision, along with some undeveloped areas. According to the topographic map, the subject project area is located within a drainage area of a tributary to the Okatie River; however, the tributary on the map no longer appears to exist. Island West Drive, which is the road adjacent to the project area, appears to have been constructed in or near the location of the tributary shown on the topographic map. The golf course ponds also appear to be near the location of the tributary shown on the topographic map. The Okatie River is located both west of and south of the subject project area wetlands, which are approximately 2,300 feet from the Okatie River in both directions. The wetland soils are mapped as being Bladen fine sandy loam, which are “All Hydric.” The Bladen soils of the subject project area wetlands are part of a larger soil mapping unit that continues to the Okatie River both to the west and south. The National Wetland Inventory Maps (NWI) shows wetlands in the undeveloped/forested areas between the project area wetlands and the Okatie River to the west and the Okatie River to the south. In addition, the subject project area is located within the boundaries of a previous Corps permit project area (SAC 26-90-956). The previous permit drawings appear to depict wetlands within the areas mapped as Bladen soils and NWI wetlands. Based on this information, the wetlands located within the subject project area were determined to be wetlands adjacent to a TNW (Okatie River) and therefore are subject to regulation under Section 404 of the Clean Water Act.**

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
