If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of aerial photography, soil survey information, topographic maps, NWI maps, and supplemental information submitted by the consultant, it has been determined that the referenced property does not contain any wetland areas or other waters of the United States. Soil survey depicts the site as Leon which is a hydric soil. However, the soils depicted in the consultants pictures and on the data sheets are more representative of a Chipley soil (non-hydric) which, according to the soil survey map, borders the northern property boundary. The site is mapped as uplands on the NWI map and there are no wetland areas or blue lines (tributaries) depicted on topographic maps. A site visit was not conducted.
