

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands located within the review have been previously placed in restrictive covenants as mitigation for impacts associated with DA permit # 26-97-0740-G. The onsite wetlands total 1.37 acres with 0.44 acres of associated upland buffers. Wetlands were determined to be adjacent to the TNW (AIWW). No other aquatic resources were identified during the site evaluation of the project site. The does contain several non-jurisdictional upland excavated ditches that drain only uplands and/or do not display an OHWM.
