**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Provide data and rationale indicating that tributary is perennial: **Flow of the on-site tributary (Unnamed Tributary of Shot Pouch Creek) was determined to be**

perennial due to the presence of the flow of water outside of the wet season under drought conditions and by identification of many indicators of perennial flow. Stream geomorphic indicators of perennial flow were a well-defined channel within bed and banks and presence of an OHWM. Live submerged aquatic vegetation and other aquatic vegetation was observed growing within the bottom channel, which was approximately 6.5' wide at the bottom. Throughout the center of the channel a lack of vegetation was evident due to the flow of water. Also, in the center of the channel, a consolidated sandy bottom was discovered near the surface of the soil. Due to a slower velocity of flow, some muck was observed above the sandy consolidated bottom, less than an inch in the main channel and up to 6" near the bottom of the bank. Some scouring was evident on the banks adjacent to the channel. Topographic maps depict this reach as a solid blue line. Aerial photos do not show any inundation or evidence of a stream due to canopy cover. Flow enters the property from the south and continues north, turns within the review area to continue off-property in a west-southwest direction until it joins another perennial RPW (Shot Pouch Creek) and continues toward Green Swamp (perennial RPW) which continues in an east-southeast direction and drains into the Pocatigo Swamp (perennial RPW), providing a hydrologic connection to the Black River (TNW).

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. The site visit was performed during a drought period. The prevalence of hydrophytic vegetation was documented. Hydric soils meeting the F3 indicator were observed, but no surface or subsurface hydrology indicators were observed within the review area. No wetlands were discovered within the review area. Flow of the on-site tributary (Unnamed Tributary of Shot Pouch Creek) was determined to be perennial due to the presence of the flow of water outside of the wet season under drought conditions and by identification of many indicators of perennial flow. Stream geomorphic indicators of perennial flow were a well-defined channel within bed and banks and presence of an OHWM. Live submerged aquatic vegetation and other aquatic vegetation was observed growing within the bottom channel, which was approximately 6.5' wide at the bottom. Throughout the center of the channel a lack of vegetation was evident due to the flow of water. Also, in the center of the channel, a consolidated sandy bottom was discovered near the surface of the soil. Due to a slower velocity of flow, some muck was observed above the sandy consolidated bottom, less than an inch in the main channel and up to 6" near the bottom of the bank. Some scouring was evident on the banks adjacent to the channel. Topographic maps depict this reach as a solid blue line. Aerial photos do not show any inundation or evidence of a stream due to canopy cover. Flow enters the property from the south and continues north, turns within the review area to continue off-property in a west-southwest direction until it joins another perennial RPW (Shot Pouch Creek) and continues toward Green Swamp (perennial RPW) which continues in an east-southeast direction and drains into the Pocotaligo Swamp (perennial RPW), providing a hydrologic connection to the Black River (TNW). An additional seasonal water of the United States is described in Form 2 of 2. Two (2) linear features were observed on the subject property and were determined to have bed and banks but did not have an OHWM. The linear features were determined to be non-jurisdictional ditches. No other potentially jurisdictional features were observed within the review area.**
