**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The onsite wetland (0.72 acres) was determined to be isolated due to its lack of physical, chemical, and biological connection to other wetlands or Waters of the US (WOUS). Although it meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2009 Coastal Plain Supplement, all water onsite drains toward this wetland but has no discernable or traceable outfall or connection to other Waters of the US. Additionally, the wetland in review was found to be encompassed primarily by upland soils (Centenary). Chemically this wetland does not affect any water of the US in the absorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of this wetland and its relation to other jurisdictional waters of the US is such that water in this wetland is retained and eventually percolated through the soil to groundwater only, to an unknown depth, providing little if any storm water attenuation. An examination of aerial photography, NWI wetland maps, and Georgetown County Soil Survey information concur that wetland is separated from other waters of the US physically, and chemically. Additionally, this site is approximately 1900 linear feet from the nearest jurisdictional feature, an unnamed tributary of Pawleys Inlet.
