There is a \sim 2' drop at the MHW line down to the tidal wetlands. The site topography drains towards the TNW, therefore, surface and subsurface flow would be expected to drain from the wetlands to the TNW. Consequently, the wetlands are adjacent to the TNW and are jurisdictional.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are two small freshwater wetlands (A=0.084 ac. and B=0.029 ac) on site at the northern end of the property adjcent to the tidal waters of Rantowles Creek. The wetlands are within ~10' of the MHW line and there is ~2 ' drop at the MHW line down to the tidal wetlands. Site topography drains down to the tidal wetlands and it is expected that surface and subsurface flow would drain to the TNW. Therefore, based on a site visit, aerial photo, quad/topo chart, soils and NWI, the two wetlands are considered adjacent to the TNW and jurisdictional.
