The site is a 70.50-acre tract of second-growth pine hardwoods set on a topographic plateau between the Okatee and New River drainages in eastern Jasper County, South Carolina. The site uplands have a Loblolly Pine-dominated canopy over a diverse group of sandy soils (*Coosaw*, *Bladen*, *Wahee*) consistent in color and un-coated grain structure with the NRCS map listings. The wetlands show a higher density of canopy hardwoods and hydrophytic shrub mid-story over low-chroma, heavily streaked and saturated soils.

Wetlands B & C are circular, small depressions with no natural or manmade outlets with high water marks on the hardwoods and Baldcypress tree trunks. They have low-chroma and saturated soils lying within shallow, well defined topographic basins. These areas show no hydrologic surface connections (natural or man-made) beyond their basins. Wetland A has a higher proportion of hydrophytic hardwoods in the canopy (Sweetgum, Laurel Oak) over soils that here are consistent with the mapped hydric *Cape Fear* series.

Regarding Wetland A, during the site inspections of both 2006 and 2011, no offsite surface connection (natural or man-made) can be identified that connects Wetland A to the New River drainage to the southwest (or offsite at all). The adjacent southern properties have been cleared, graded and planted to pines more than 15 years ago, followed by partial harvest and road preparation for an industrial park. Hydrologic indicators and volunteer plant species in the area do not indicate shallow surface movement of water from the subject site. No wetland drainage culvert has been set in SC 462 on the topographic alignment to the southwest or under any other perimeter road.

There is no evidence of surface flow from Wetland A (or B or C) beyond the boundaries of the site. Soil sampling around the perimeters of B & C and south of A, to depths of about two feet, did not show evidence of color, texture or water table that that would indicate a shallow subsurface hydrologic connection exists beyond the platted wetland boundaries.

Borrow Pits 1 & 2 show a ~3ft. cut-bank profile and high-chroma soils characteristic of borrow pits derived from uplands for area road construction. They are not subject to Clean Water Act regulation.

This property (at a slightly larger acreage) was delineated and a jurisdiction determination made in 2006 (SAC 81-2005-1982-1NQ). That delineation & determination are consistent with the current observations that the subject wetlands do not drain or extend offsite. The near-level landscape position of the property, along a plateau between watersheds and proximally distant from natural or manmade drainages, prevents Wetlands A, B & C from making compelling biological, chemical or physical contributions to either the TNW Okatee River or the New River watersheds. These wetlands are therefore isolated from waters of the US and not subject to Clean Water Act jurisdiction.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The site is a 70.50-acre tract of second-growth pine hardwoods set on a topographic plateau between the Okatee and New River drainages in eastern Jasper County, South Carolina. The site uplands have a Loblolly Pine-dominated canopy over a diverse group of sandy soils (*Coosaw, Bladen, Wahee*) consistent in color and un-coated grain structure with the NRCS map listings. The wetlands show a higher density of canopy hardwoods and hydrophytic shrub mid-story over low-chroma, heavily streaked and saturated soils.

Wetlands B & C are circular, small depressions with no natural or manmade outlets with high water marks on the hardwoods and Baldcypress tree trunks. They have low-chroma and saturated soils lying within shallow, well defined topographic basins. These areas show no hydrologic surface connections (natural or man-made) beyond their basins. Wetland A has a higher proportion of hydrophytic hardwoods in the canopy (Sweetgum, Laurel Oak) over soils that here are consistent with the mapped hydric *Cape Fear* series.

Regarding Wetland A, during the site inspections of both 2006 and 2011, no offsite surface connection (natural or man-made) can be identified that connects Wetland A to the New River drainage to the southwest (or offsite at all). The adjacent southern properties have been cleared, graded and planted to pines more than 15 years ago, followed by partial harvest and road preparation for an industrial park. Hydrologic indicators and volunteer plant species in the area do not indicate shallow surface movement of water from the subject site. No wetland drainage culvert has been set in SC 462 on the topographic alignment to the southwest or under any other perimeter road.

There is no evidence of surface flow from Wetland A (or B or C) beyond the boundaries of the site. Soil sampling around the perimeters of B & C and south of A, to depths of about two feet, did not show evidence of color, texture or water table that that would indicate a shallow subsurface hydrologic connection exists beyond the platted wetland boundaries.

Borrow Pits 1 & 2 show a ~3ft. cut-bank profile and high-chroma soils characteristic of borrow pits derived from uplands for area road construction. They are not subject to Clean Water Act regulation.

This property (at a slightly larger acreage) was delineated and a jurisdiction determination made in 2006 (SAC 81-2005-1982-1NQ). That delineation & determination are consistent with the current observations that the subject wetlands do not drain or extend offsite. The near-level landscape position of the property, along a plateau between watersheds and proximally distant from natural or manmade drainages, prevents Wetlands A, B & C from making compelling biological, chemical or physical contributions to either the TNW Okatee River or the New River watersheds. These wetlands are therefore isolated from waters of the US and not subject to Clean Water Act jurisdiction.
