C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This feature is approximately 4 feet wide, 4 feet deep and 735 feet long. Since the source of water draining from this feature was readily observed to be a stormwater detention pond, no flow was noted on the day of the site visit, there was no ordinary high water line and no wetland vegetation in the floor of the ditch, this feature was determined to be non-jurisdictional.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: The jurisdictional wetlands on this property are abutting and associated with Rumphs Hill Creek. Rumphs Hill Creek, an RPW that flows into the Ashley River (TNW), forms the southern boundary of the tract. The jurisdictional wetlands abutting Rumphs Hill Creek are regulated by the Clean Water Act.
