Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Isolated wetlands onsite totaled 10.13 acres (Wetlands ISO 1-9). These wetlands are determined to be isolated due to their lack of physical, chemical, and biological connection to other wetlands or Waters of the US (WOUS). Although they meet the criteria set forth in the 1987 Wetland Delineation Manual and the 2009 Coastal Plain Supplement, surface water

entering these wetlands have no discernable or traceable outfall or connection to other Waters of the US. The wetlands were found to be isolated because they are encompassed by soils that do not meet the hydric soil criteria, and the absence of hydrologic connection to any other WOUS. Chemically these wetlands do not affect any WOUS in the absorption / treatment of nutrients, runoff, and pollutants. Physically, their topographic / geomorphic positioning and relationship to other jurisdictional waters of the US is such that water entering and contained in these wetlands are retained and eventually percolated through the soil to groundwater only, to an unknown depth, providing an undetermined benefit to storm water attenuation. An examination of aerial photography, NWI wetland maps, Georgetown County Soil Survey, and Georgetown County LIDAR topographic contour data concurs that these wetlands are separated from other waters of the US physically, and chemically.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
