If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The downstream portions situated north of E CCC Road & Kiawah Road was determined to be a TNW in 2007-01147-3JH dated October 25, 2007 that eventually discharge directly into the Sampit River. .

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the criteria set forth in the 1987 Wetland Delineation Manual. The offsite feature, which wetlands J1, J2, J4, J5, & J6 (40.11 acres) abutt, is a named tributary (Turkey Creek) on USGS topographic maps. Year round continual flow is obvious from aerial photography and it is depicted as a solid blue line on USGS topographic maps. Additionally, this tributary was impounded between E CCC Road & Kiawah Road, removing its tidal influence but continues to serve as a perennial conveyance. The downstream portions situated north of E CCC Road & Kiawah Road was determined to be a TNW in 2007-01147-3JH dated October 25, 2007 that eventually discharge directly into the Sampit River.**
