C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The January 26, 2012 site inspection found the 5.25-acre track to be a second-growth upland pine-hardwood forest with understory shrub heads dispersed between old, cleared agriculture fields. The remaining tree canopy was dominated by mature Longleaf and Loblolly Pines, Live and Water Oaks, and Sweetgum trees; a variety of typical shrubs (myrtle, groundsel, American Beauty-berry) were also present. The old farm fields and borders showed high-chroma soils, were dominated by several *Panicum* grasses, and showed occasional recruitment by hardwoods and pine saplings. The old field structure was still evident.

Wetlands occurred along a topographic drain to the east of the site, but the jurisdictional wetland edge (low-chroma – 2/3, 2/4- soils, mature gum and cypress trees) was 40-60 feet beyond the property line.

The site does not contain waters of the US and is not subject to Clean Water Act jurisdiction.
