C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A review of available electronic resources included aerial imagery (including infrared photography), USGS Topo maps, NWI maps, and soils maps. The site is shown on USGS Quad Maps as forested. On the

1999 infrared aerial photograph, the site appears to be forested and has a heat signature consisted with documented upland forested areas. The NWI maps depict the site as PFO1/4B, wetlands. The soils are mapped as Lynchburg and Rains (hydric) soils. An onsite investigation was conducted within a period of extreme drought (87% below normal rainfall). The review area was evaluated using the 1987 Delineation Manual and Regional Supplement. A prevalence of hydrophytic vegetation was present, however no hydrology or hydric soil indicators were discovered on the subject property. No potentially jurisdictional features were observed on the subject property and the site was determined to be entirely uplands.
