C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

information obtained during the site visit and a review of the aerials and topographic map. The aerials depict this tributary as a shaded linear feature located along the western property boundary of the site, and the topographic map depicts this tributary as a solid blue line named Gin Branch. During the site visit, this tributary was viewed upstream and downstream of its intersection with Browntown Road and was observed to have a sinuous channel within the stream bed with a firm, sandy bottom. Within the stream banks, this tributary is approximately 15' wide. According to the topographic map, this tributary continues southeast until it intersects with the Black River.

B. ADDITIONAL COMMENTS TO SUPPORT JD: According to the NWIs, soil survey, aeriels, topo map, and site visit, Wetland "A" directly abuts the perennial RPW labeled "PRPW-1" on the plat. The soil survey depicts this area as "Mixed Alluvial Land," which is a hydric soil, and the NWIs map this wetland as PF01B. The topographic map depicts a solid blue line intersecting the location of the wetland at the western property boundary of the site. During the site visit, the boundary of Wetland "A" was verified and determined to intersect the boundary of "PRPW-1"

The tributary labeled "PRPW-1" on the plat was determined to have perennial flow based on information obtained during the site visit and a review of the aeriels and topographic map. The aeriels depict this tributary as a shaded linear feature located along the western property boundary of the site, and the topographic map depicts this tributary as a solid blue line named Gin Branch. During the site visit, this tributary was viewed upstream and downstream of its intersection with Browntown Road and was observed to have a sinuous channel within the stream bed with a firm, sandy bottom. Within the stream banks, this tributary is approximately 15' wide. According to the topographic map, this tributary continues southeast until it intersects with the Black River..
