The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A potentially jurisdictional linear feature and pond were also assessed within the review area and determined to be non-jurisdictional. The linear feature (depicted as Ditch 3 on the plat) is located northeast of PRPW-2 and does not provide a connection for any other potential waters of the US. This linear feature connects downstream to a man-made stormwater retention pond that was also excavated out of uplands, according to the previous JD and the NWIs and soil survey. This stormwater pond is depicted as "Upland Dug Pond - 3" on the plat and connects via a concrete culvert to PRPW-2.

The tributary labeled "PRPW-2" on the plat was determined to have perennial flow based on information obtained during the site visit and a review of the aerials. The aerials depict this tributary as a shaded linear feature located along the western property boundary of the site. The PRPW-2 is not depicted on the topographic survey; however, this tributary was viewed during the site visit and determined to have perennial flow based on the observation of approximately 18" of flowing water in the channel and sediment deposition. The channel was mostly free of leaf litter and debris. This tributary is approximately 3' wide and flows south into Gin Branch near the southwestern property boundary.
