Explain: **A potentially jurisdictional wetland was previously determined by the Corps to be jurisdictional in a letter dated April 30, 1998, (SAC-1997-33204, fka 80-97-0038), which was extended on May 12, 2005, and expired on May 12, 2010. This wetland is depicted as "Tract No. 2" on the plat and is mapped palustrine forested wetland (PF01B) on the**

NWIs and Rains, a hydric soil, on the soil survey. The wetland boundary was verified during the site visit and the southern portion of the wetland continues south off of the project site. The eastern, northern, and western boundaries of this wetland were examined and found to be surrounded by uplands with no potential connection to any waters of the US. According to the topographic map, a blue line is depicted as intersecting the property at the location of this wetland and continuing southeast off of the project site. During the site visit, a linear feature was observed exiting the southern portion of the wetland. This feature has a bed and banks but no ordinary high water mark and non-hydric soils were found in the bottom of the feature. Dry leaf litter and debris were observed in the bottom of the feature and terrestrial vegetation was growing in the bottom of the feature. This linear feature continues southeast through uplands to its intersection with Laverne Avenue. However, no culvert could be located at Laverne Ave. that would provide a potential connection from this linear feature to the downstream TNW. According to the surveyor, a survey completed in 1988 indicates that the original culvert at this crossing was closed off, and, during the site visit, 2' high brick structures were observed on either side of Laverne Ave. within the linear feature. South of Laverne Ave., this linear feature continues southeast; however, no indicators of flow were observed within the feature immediately south of the street. Because this wetland is not adjacent to any other waters of the US and has no hydrologic connection to a downstream RPW, this wetland was determined to be isolated .

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The wetland boundary was verified during the site visit and the southern portion of the wetland continues south off of the project site. The eastern, northern, and western boundaries of this wetland were examined and found to be surrounded by uplands with no potential connection to any waters of the US. According to the topographic map, a blue line is depicted as intersecting the property at the location of this wetland and continuing southeast off of the project site. During the site visit, a linear feature was observed exiting the southern portion of the wetland. This feature has a bed and banks but no ordinary high water mark and non-hydric soils were found in the bottom of the feature. Dry leaf litter and debris were observed in the bottom of the feature and terrestrial vegetation was growing in the bottom of the feature. This linear feature continues southeast through uplands to its intersection with Laverne Avenue. However, no culvert could be located at Laverne Ave. that would provide a potential connection from this linear feature to the downstream TNW. According to the surveyor, a survey completed in 1988 indicates that the original culvert at this crossing was closed off, and, during the site visit, 2' high brick structures were observed on either side of Laverne Ave. within the linear feature. South of Laverne Ave., this linear feature continues southeast; however, no indicators of flow were observed within the feature immediately south of the street. Because this wetland is not adjacent to any other waters of the US and has no hydrologic connection to a downstream RPW, this wetland was determined to be isolated .
