If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The eastern portion of the project boundary was determined to be a jurisdictional wetland that directly abuts an offsite perennial RPW based on a review of the aerials, topographic map, soil survey, and NWI map. The onsite wetland, depicted as "Tract No. 3" on the plat, is a portion of a larger wetland system located east of the project site. The aerials and topographic map depict a linear feature located east of the project boundary. The soil survey depicts the onsite wetland and the continuation of the wetland system east of the project boundary as Rains and Hyde, which are both hydric

soils. The NWI maps this wetland system as a palustrine forested wetland (PF01Bd and PF01Cd). The wetland system directly abuts an offsite perennial RPW, which is depicted as a solid blue line on the topographic map. This perennial RPW is an unnamed tributary of Brunson Branch, a pRPW, which flows into Rocky Bluff Swamp. Rocky Bluff Swamp is a perennial RPW that flows directly into the Black River.
