Explain: **According to the soil survey, the majority of the site is mapped Ponzer, which is a hydric soil. The NWI maps this site as uplands (U42P) and the topographic map does not depict any wetlands on site. Soil samples taken during the site visit determined that hydric soils are not present on site due to the presence of greater than 30% uncoated sand**

grains in the upper 4-6". The soils were observed to be 10YR 3/1 in the upper 20" and were predominately sand. Hydrophytic vegetation was present on site and a review of rainfall data shows this area has less than average rainfall and has been in a moderate to severe drought since June, 2011. However, hydrology cannot be assumed based on the presence of a tributary on site and tributaries located north, south, and west of the project site. Based on the lack of hydric soils and hydrology on site, the site was determined to have no wetlands present.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The streambed has hydric soils that are saturated to the surface. During the site visit, this tributary was observed to have a layer of muck over a sandy bottom with water stained leaf litter and debris in the streambed at the upstream end near the northern property boundary. The tributary was also viewed at the downstream end (southern property boundary) and found to have a more defined channel free of leaf litter and debris and sediment sorting.
