C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Sixteen (16) lots within the southern portion of Knights Village Subdivision were determined to have no wetlands or other waters of the US within their boundaries. The topographic map and aerial depict wetlands immediately south of the property boundary and the soil survey maps the project area as Troup, a non-hydric soil.

According to the soil survey, Rutledge, a hydric soil, is mapped immediately south of the property boundary, and the NWIs depict the southwestern portion of the project area as wetlands (PSS3B) and the remainder of the project area as uplands (U11). During the site visit, the stakes for the property corners were located and the agent's flagged wetland boundary, located south and off of the property, was verified. No hydric soils or hydrology indicators were observed within the property boundary of the site; therefore, this site was determined to consist entirely of uplands..
