## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The isolated wetland is assessed on JD Form 1 of 2. The wetland assessed on this form is approximately 7.3 acres and directly abuts the Waccamaw River (TNW). The wetland continues off-site to the north until it intersects the Waccamaw River. According to aerial imagery and topographic maps, there is also a tributary beginning off-site within the wetland that flows directly into the Waccamaw River. The tributary is depicted as a solid blue line on topographic maps and inundation is visible on aerial photography suggesting that the tributary flows year-round. The RPW observed in the field is approximately 1,000' long and 4' wide. It appeared to be a man-altered tributary. The tributary has been straightened and maintained. It is depicted as a solid blue line on topographic maps. Flow of the onsite tributary was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow were channel within bed and banks had a firm sandy bottom, OHWM (line impressed on the bank), clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream. Flowing water was observed during the site visit .
