Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: An upland cut drainage ditch was noted in the center of the subject property which drains water from a stormwater detention pond at Pinewood Preparatory School to Rumphs Hill Creek. This feature is approximately 15

feet wide, 4 feet deep and 450 feet long. Since the source of water draining from this feature was readily observed to be a stormwater detention pond, no flow was noted on the day of the site visit, there was no ordinary high water line and no wetland vegetation in the floor of the ditch, this feature was determined to be non-jurisdictional. Additionally, 12 other man-made conveyances, including road side ditches and drainage swales, were noted and determined to be non-jurisdictional since they displayed no active flow and had no ordinary high water marks. These features generally ranged from one to two feet deep, four inches to two feet deep, and have a total length of 2,828 feet.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
