- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Four (4) isolated wetlands (W-3 = 0.96 acres; W-4 = 0.64 acre; W-5 = 3.75 acres; W-6 = 1.20 acres) were assessed within the review area totaling 6.55 acres. A review of infrared aerial photographs, soil maps, and NWI maps prior to the site visit determined that these area were potentially jurisdictional wetlands. The wetland boundaries were**

verified during the site visit on December 12, 2011 using the 1987 Delineation Manual. Hydric soils, a prevalence of hydrophytic vegetation, and hydrology indicators such as moss trim lines, drainage patterns, high water marks on tree trunks, and saturation within the upper 12" were observed. Areas determined to be uplands were atypical as they were all in managed pine plantation. No hydrology indicators were observed within the surrounding uplands. During the site visit, an investigation surrounding the wetlands revealed that no surface or shallow subsurface hydrologic connections existed between these wetlands and jurisdictional wetlands (W-1 and W-2) and waters of the US (pRPW#1) on the subject property which are described in Form 1 of 2 or any other off-site aquatic resources. A series of man-made non-jurisdictional ditches on the subject property were observed and also did not serve as hydrologic connections. These features are also described on Form 1 of 2. No additional features were observed within or around "W-3, W-4, W-5, or W-6" nor are any features depicted on maps or aerial photographs which were reviewed during the investigation. These depressional wetland areas retain water within the wetland boundary and have no evidence of a chemical or biological connection to other waters of the US; therefore, "W-3, W-4, W-5, and W-6" were determined to be non-jurisdictional.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. The site visit was conducted during a period of drought well below normal climatic conditions. Four

(4) isolated wetlands (W-3 = 0.96 acres; W-4 = 0.64 acre; W-5 = 3.75 acres; W-6 = 1.20 acres) were assessed within the review area totaling 6.55 acres. A review of infrared aerial photographs, soil maps, and NWI maps prior to the site visit determined that these areas were potentially jurisdictional wetlands. The wetland boundaries were verified during the site visit on December 12, 2011 using the 1987 Delineation Manual. Hydric soils, a prevalence of hydrophytic vegetation, and hydrology indicators such as moss trim lines, drainage patterns, high water marks on tree trunks, and saturation within the upper 12" were observed. Areas determined to be uplands were atypical as they were all in managed pine plantation. No hydrology indicators were observed within the surrounding uplands. During the site visit, an investigation surrounding the wetlands revealed that no surface or shallow subsurface hydrologic connections existed between these wetlands and jurisdictional wetlands (W-1 and W-2) and waters of the US (pRPW#1) on the subject property which are described in Form 1 of 2 or any other off-site aquatic resources. A series of man-made non-jurisdictional ditches on the subject property were observed and also did not serve as hydrologic connections. These features are also described on Form 1 of 2. No additional features were observed within or around "W-3, W-4, W-5, or W-6" nor are any features depicted on maps or aerial photographs which were reviewed during the investigation. These depressional wetland areas retain water within the wetland boundary and have no evidence of a chemical or biological connection to other waters of the US; therefore, "W-3, W-4, W-5, and W-6" were determined to be non-jurisdictional.
