

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

determined to be perennial due to the presence of the flow of water outside of the wet season under drought influenced climatic conditions and by identification of many indicators of perennial flow. The feature was man-altered and was approximately 3' deep by 5' wide. Stream geomorphic indicators of perennial flow were a well-defined channel within bed and banks and presence of an OHWM. The bottom channel was approximately 3' wide at the bottom and discrete flow was observed during the time of the site visit. Throughout the center of the channel a lack of vegetation was evident due to inundation to approximately 2' and the flow of water. Due to the presence and flow of water during a drought period, it has been determined that this feature intercepts ground water. Due to a slower velocity of flow, muck was observed within the bottom channel. This season's leaves and debris were discovered in the bottom channel, as they had been carried downstream by the flow of water. Topographic maps do not depict this reach. Aerial photos show the presence of inundation of water and also show that the feature continues onto adjacent property where it turns to the east, entering into a wetland system which intercepts the MHW of the Great Pee Dee River (TNW).

completed jurisdictional determination for adjacent property to the north and can be found in SAC # 2011-00664-4JH, Phase 1 of the Woodland Forest (Form 1 of 2) dated November 15, 2011.

ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were established by the 1987 B. Delineation Manual. A prevalence of hydrophytic vegetation, multiple hydrology indicators, and hydric soils were observed within the flagged wetland boundary which was verified. Wetlands flow is to the Great Pee Dee River (TNW). W-1 is directly abutting the TNW. W-1 flows across the north property line through an 18" CMP culvert, to enter wetlands identified as abutting the TNW on Form 1 of 2 of a previous jurisdictional determination entitled "SAC # 2011-00664-4JH, Phase 1 of the Woodland Forest." The wetland is described as W-5, which continues offsite and intersects the MHW of the Great Pee Dee River. A linear feature was observed entirely within W-2 and was determined to be a tributary water of the U.S. Flow of the on-site tributary, pRPW#1 (Unnamed Tributary of Great Pee Dee River) was determined to be perennial due to the presence of the flow of water outside of the wet season under drought influenced climatic conditions and by identification of many indicators of perennial flow. The feature was man-altered and was approximately 3' deep by 5' wide. Stream geomorphic indicators of perennial flow were a well-defined channel within bed and banks and presence of an OHWM. The bottom channel was approximately 3' wide at the bottom and discrete flow was observed during the time of the site visit. Throughout the center of the channel a lack of vegetation was evident due to inundation to approximately 2' and the flow of water. Due to the presence and flow of water during a drought period, it has been determined that this feature intercepts ground water. Due to a slower velocity of flow, muck was observed within the bottom channel. This season's leaves and debris were discovered in the bottom channel, as they had been carried downstream by the flow of water. Topographic maps do not depict this reach. Aerial photos show the presence of inundation of water and also show that the feature continues onto adjacent property where it turns to the east, entering into a wetland system which intercepts the MHW of the Great Pee Dee River (TNW). The on-site tributary, pRPW#1 (Unnamed Tributary of the Great Pee Dee River) is sited entirely within W-2, which are adjacent and directly abutting. Four isolated wetlands described as "W-3, W-4, W-5, and W-6" were assessed within the review area totaling 6.55 acres and were determined to be isolated and are described on Form 2 of 2. A series of linear features were observed on the subject property which were determined to have no OHWM and were excavated out of uplands and draining only uplands. No additional features were observed during the investigation.
