**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A review of available electronic resources included aerial imagery (including infrared photography), USGS Topo maps, NWI maps, and soils maps. The review of these resources revealed that no aquatic resources (linear features or waterbodies) are within the boundaries of the subject property. On 2009 and 2006 aerial photographs, the site appears to be entirely uplands and part of an airport facility. In the 2009 infrared aerial photograph, the area appears to be lacking indicators of hydrology (high heat signature as opposed to cool heat signature for inundated or saturated soils). The USGS Topo map depicts the site as non-forested, and as an airport facility labeled "Pageland Airport," and not in near vicinity to any forested, wetland, or blue line features. The NWI maps depict the site as U14, uplands. The soils are mapped as Alpin (non-hydric) soils. After review of the consultant's submitted data sheets and on-site photography of the soil profile on the subject property, it was determined that none of the three parameters were met based on the 1987 Manual and that subject property does not contain wetlands or any other water of the United States.
