### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based upon the information provided by the consultant and information available to the Corps, the Corps has determined that the wetlands on site are one contiguous wetland system that is abutting Big Swamp. Big Swamp flows to Collins Creek and onto the Waccamaw River (TNW). The confluence of Collins Creek and the Waccamaw River is close to the confluence with the Atlantic Ocean and experiences tidal influence.

The wetlands documented on this form include wetlands directly abutting a perennial RPW. Based on guidance in RGL 07-01, perennial RPW's and all directly abutting wetlands are subject to jurisdiction under the Clean Water Act. Therefore, this office has made the determination that the waters documented on this form are jurisdictional Waters of the U.S.
