This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The seasonal RPW (C) is located on the southern part of the property. It is performing a variety of biological, chemical, and physical functions related to the integrity of the TNW. This tributary is located near a residential development and crosses an area disturbed by a sewer line. It provides habitat for wildlife in the area and breeding grounds for aquatic species. This tributary also helps to filter pollutants from the nearby developments and roads. It collects run off during times of heavy rain and the wetter months and filters them before they head downstream to the TNW. The tributary provides flood storage during the wetter times. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the TNW, it has been determined there is a significant nexus between the tributary and the downstream TNW .
