Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are six (6) wetlands located on the subject property that were determined to be isolated and nonjurisdictional. There are three (3) linear conveyances located on the subject property that were determined to be nonjurisdictional. Two of the three non-jurisdictional linear conveyances are shallow ditches that are located on both sides of a dirt road located towards the eastern side of the subject property. These roadside linear conveyances were excavated from uplands, except for the portions that are located within isolated non-jurisdictional wetlands B and H. The roadside linear conveyances begin near the subject property boundary and disappear within the subject property when the dirt road ends. The third non-jurisdictional linear conveyance is located towards the northern portion of the subject property and begins in uplands, flows through isolated non-jurisdictional wetland B, and continues through the uplands where it disappears. The three non-jurisdictional linear conveyances do not flow to waters of the U.S. and do not have relatively permanent flow; therefore, they are not considered to be tributaries. The three linear conveyances were determined to be non-jurisdictional and not subject to Clean Water Act jurisdiction. The isolated nonjurisdictional wetlands located on the subject property are Wetland A (0.96 acres), Wetland B (2.19 acres), Wetland C (1.64 acres total, 0.82 acres located onsite), Wetland D (0.75 acres total, 0.22 acres onsite), Wetland F (0.72 acres), and Wetland H (2.08 acres). Please note that the boundaries of Wetlands C and D continue offsite. The isolated nonjurisdictional wetlands are depressional type wetlands that have no surface hydrologic connection and no apparent subsurface hydrologic connection to a water of the U.S. The isolated wetlands are completely surrounded by uplands, they have no linear conveyances flowing out of them that connect to a water of the U.S., and they are not in close proximity to a tributary or TNW. Wetlands A, B, C, D, F and H were deteremined to be isolated non-jurisdictional wetlands and not subject to Clean Water Act jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
