Explain: **The 8.26 a. site is depicted as an agricultural field on the aerials and as uplands on the NWIs (U21). However, the soil survey depicts hydric soils (Coxville) on the western and eastern portions of the site. Soil samples were taken in the western portion of the site, and non-hydric soils were observed. Soil samples within the eastern portion of the site**

found hydric soils but no indicators of hydrology were observed. Because of the presence of multiple drainage features on this site, hydrology was determined to not be present, and this site was determined to have no wetlands within the project boundary.

Three potentially jurisdictional linear features are present on site and were assessed during the site visit. Both the northern and center linear features originate within uplands on site and were observed to have no OHWM or other indicators of flow. Leaf litter, debris, and terrestrial vegetation were observed in the bottom of these two features. The center linear feature originates north of the southern property boundary and continues north where it intersects with the northern linear feature. The northern linear feature originates at the northwestern property corner and continues east along the northern property boundary. Both of these features were determined to be non-jurisdictional ditches.

The third linear feature is located along the eastern property boundary and is depicted on the topographic map as a solid blue line. This feature was observed to have water in the bottom with water stained leaf litter and debris. However, immediately downstream of the project site, at the intersection with Russell Road, this linear feature has been excavated for a water retention pond that was holding water during the site visit. The linear feature was also viewed downstream of Russell Road and found to have an OHWM with indicators of flow. Because the on-site portion of this man-made feature was determined to have less than seasonal flow, it was determined to be a non-jurisdictional ditch.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 8.26 a. site is depicted as an agricultural field on the aerials and as uplands on the NWIs (U21). However, the soil survey depicts hydric soils (Coxville) on the western and eastern portions of the site. Based on a review of the aerials, soil survey, NWIs, topographic map, and information obtained during the site visit, this site was determined to consist of uplands with no wetlands or other waters of the US present. During the site visit, three potentially jurisdictional linear features were observed and determined to be non-jurisdictional ditches. The northern and center linear features, which originate within uplands on site, were observed to have no OHWM or other indicators of flow. Leaf litter, debris, and terrestrial vegetation were observed in the bottom of these two features. The center linear feature originates north of the southern property boundary and continues north where it intersects with the northern linear feature. The northern linear feature originates at the northwestern property corner and continues east along the northern property boundary. The third linear feature, which is located along the eastern property boundary and is depicted on the topographic map as a solid blue line, was observed to have water in the bottom with water stained leaf litter and debris. However, immediately downstream of the project site, at the intersection with Russell Road, this linear feature has been excavated for a water retention pond that was holding water during the site visit. The linear feature was also viewed downstream of Russell Road and found to have an OHWM with indicators of flow. Because the on-site portion of this man-made feature was determined to have less than seasonal flow, it was also determined to be a non-jurisdictional ditch.
