C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

information, and NWI maps, as well as three (3) previous determinations (Ref: SAC# 2008-00782-3JC, 2008-00311-3JH, and 84-2004-1042), the CCC Canal along the western property boundary was determined to be a perennial RPW with flow at least 90% of the year. The CCC Canal is a man-made tributary that provides drainage for its adjacent wetlands. Stream geomorphic indicators of perennial flow where channel within bed and banks had a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream and water flowing under drought conditions. In addition, other hydrologic indicators observed were an even distribution of substrates in the stream channel.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site is 1.85 acres and consists of 151.46 linear feet of jurisdictional waters of the U.S. (perennial RPW). The RPW is known as the CCC Canal. Based on an on-site visit and a review of aerial photography, topographic maps, soil survey information, and NWI maps, as well as three (3) previous determinations (Ref: SAC# 2008-00782-3JC, 2008-00311-3JH, and 84-2004-1042), the CCC Canal along the western property boundary was determined to be a perennial RPW with flow at least 90% of the year. The CCC Canal is a man-made tributary that provides drainage for its adjacent wetlands. Stream geomorphic indicators of perennial flow where channel within bed and banks had a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream and water flowing under drought conditions. In addition, other hydrologic indicators observed were an even distribution of substrates in the stream channel. A ditch along the northern property boundary was also observed in the field and determined to non-jurisdictional. The ditch was excavated entirely out of uplands and drains only uplands.
