This ditch is partially lined with rip rap and concrete in the bed and along the banks. It has no natural flow and terminates at a pump house which pumps the ditch water level down to an unknown location once it reaches a certain water level. In addition there are non-jurisdictional drainage ditches depicted on a supplemental drawing in the project file that run along the north and south side of an old railroad berm between Playground Road and Highway 61. SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

Critical Area 1 is connected to Critical Areas 2 and 3 via a culvert under 5th Avenue.

Summarize rationale supporting conclusion that wetland is "adjacent": Wetland A is a freshwater wetland that flows directly into Wetland B via a culvert under Highway 61 and is also adjacent to the TNW. Wetland B is contiguous with the salt marshes of the Ashley River (Critical Areas 1, 2, and 3).

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The drainage ditch parallel to and crossing Playground Road is a deep cut ditch that is partially lined with concrete and rip rap in the bed and along the banks. It has no flow and terminates at a pump house which regulates its water level. Upon reaching a certain level, the pumps activate and drain the ditch pumping water to an unknown location. The drainage ditches that run along the north and south side of an old railroad berm have no signs of flow, do not meet the three parameters, are vegetated and mowed, and had no signs of water during the site visit. Wetland A flows directly into Wetland B via a culvert under Highway 61 and is adjacent to the TNW. Wetland B is contiguous with the salt marshes of the unnamed tidal creek to Old Town Creek (Critical Areas 1, 2, and 3) which are subject to the ebb and flow of the tide. Critical Area 1 is contiguous with Critical Areas 2 and 3 via a culvert under 5th Avenue.
