visit, intersects the project site along the northern portion of the property. The upstream end of this feature terminates within uplands along Airport Road with no OHWM or culvert observed. The downstream end also has no OHWM; however a culvert was located at this end. The center portion of this linear feature has an OHWM and water was observed; however the bottom consisted of muck and no channel within bed and banks was observed. A review of the ORM data shows that a previous determination of "no permit required" was issued for filling and piping the downstream portion of this feature for a project known as the Sumter Airport Runway Extension (SAC 2006-02562). Because this man-made feature was excavated out of uplands and drains uplands; it was determined to be a non-jurisdictional ditch. A review of the topographic map does not depict this linear feature. .

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
