approach to the railroad viaduct is 360 feet long, approximately 12 feet wide and two feet deep. The second ditch along the southern boundary adjacent to the railroad tract is 900 feet long, approximately 15 feet wide and three feet deep. These upland dug ditches have not been maintained and do not display an ordinary high water mark. Portions of these ditches contained standing water, but there was no flow. Since the ditches were dug from uplands and displayed no ordinary high water lines, they were determined to be non-jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

At the time of the site visit (12-12-2012), this feature was flowing and displayed an ordinary high water mark, aquatic vegetation and debris deposited by past flow events. There are two 42" concrete culverts that allow this feature to flow under Montague Avenue. Flow is assumed to be perennial since the feature is mapped as a blue-line stream by USGS and flow was observed during a period of abnormally low rainfall.
