C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Area in review contained no Waters of the U.S. (WOUS) to include wetlands. This site is comprised of the soil type Leon (100% hydric). No wetland hydrology was present throughout the site although the site did have hydric soils and hydrophytic vegetation. Therefore, the three parameters which define a wetland are not present. Georgetown county NWI data depict the site as U11 (uplands) and PFO4B (wetlands). The project site was approximately 500 linear feet from the nearest WOUS. USGS topographic information and aerial photography depict the site as being a well drained upland forested site surrounded by commercial / residential development.

Located onsite were two upland excavated ponds and an upland excavated ditch, all of which are considered non-jurisdictional. Each of these features lacked any characteristics of a WOUS.
