### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

M and E, occurs within the project area and connects the jurisdictional wetlands together just outside the boundary of the project area. The RPW canal continues beyond the project area through wetlands and lagoons until it reaches a weir structure that funnels water under Marshland Road into the TNW, Broad Creek. It is observable in aerial photographs and was observed to be flowing in both site visits, December 8, 2011, and March 28, 2012, indicating year-round flow. There are a total of 0.46 acres of freshwater wetlands and 0.06 acres of waters of the U.S. that are located within this 29.6 acre project area that are adjacent to this RPW that flows directly into the nearby TNW, Broad Creek. Broad Creek is a Section 10 water body subject to the ebb and flow of the tide. In addition, the project area is located on a barrier island, Hilton Head Island.
