Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A 2.43 acre wetland was assessed within the review area and determined to be isolated based on a site visit and a review of the aerials, topographic map, and soil survey. The aerials and soil survey depict a depressional wetland with hydric soils (Osier) surrounded by non-hydric soils (Pocalla). The topographic map does not depict any changes

in topography surrounding the isolated wetland or blue lines or other potential WOUS within or adjacent to the isolated wetland. A 12.5 acre lake, depicted on the 1975 aerials located in the Dillon Co. Soil Survey, is located immediately north of the project site; however, during the site visit, the soils located between the off-site lake and the isolated wetland were determined to be non-hydric and no shallow subsurface connection was observed. The NWIs depict the isolated wetland and surrounding site as uplands (U42P & U21). During the site visit, the boundary of this wetland was investigated and is completely surrounded by uplands with no surface or subsurface connection to other waters of the US. Therefore, this wetland was determined to be an isolated, non-jurisdictional wetland.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
