#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). The off-site tributary was determined to have perennial flow based on a review of the aerials, topographic map, soil survey, NWIs, and a previous jurisdictional determination (SAC 2010-00917-4E). The off site tributary is depicted on the aerials as a shaded linear feature and on the topo as a blue line, which is indicative of a tributary. The area surrounding this tributary is depicted on the NWIs and soil survey as wetlands (PF01/3Bd) with hydric soils (Pantego). This tributary originates from a lake located north and adjacent to the project site and flows southeast where it intersects with Catfish Canal, a perennial RPW. Catfish Canal joins Smith Swamp and becomes Catfish Creek, which flows into the Great Pee Dee River (TNW). This off-site tributary was previously determined to have perennial flow and, along with approximately 260 acres of adjacent wetlands, to have a significant nexus to the downstream TNW in SAC 2010-00917-4E.
